Narrative:

On 5/30/20 at approximately 1500 hours, PO McQuillen and I (R#TAC36) were on duty in the area of 47th St and JC Nichols Pkwy where we were monitoring a protest at Mill Creek Park.

During the protest, rocks and water bottles were thrown at officers at which time all the protesters were given the verbal command to remain on the sidewalk and out of the street. After the verbal announcement was given MADDOX was observed stepping into the street, myself and several other KCPD officers approached MADDOX and requested him to return to the sidewalk at which time he complied. MADDOX was then observed stepping off the sidewalk again moments later at which time several others from the protest followed his lead. They were then advised by myself and several KCPD officers to return to the sidewalk. MADDOX was also advised if he stepped into the street again he would be arrested. Moments later, MADDOX was observed stepping into the street again at which time myself, PO McQuillen and several KCPD officers approached MADDOX as PO McQuillen advised MADDOX that he was under arrest. As we got within arms reach of MADDOX, he stepped onto the curb and away from approaching officers. PO McQuillen then reached with his right hand and grasped MADDOX by the right elbow as I reached and grasped the left arm of MADDOX. As I grabbed the left arm of MADDOX, I could feel him pull away from me which caused his left shirt sleeve to rip at which time it was then observed by PO McQuillen that others inside the crowd were attempting to assist him pulling away from us. PO McQuillen then observed a female directly to the right side of MADDOX loudly yell "No!" while placing her hand on PO McQuillen's vest and pushing him away in an apparent attempt to stop him from affecting an arrest. PO McQuillen had a MK-9 pepper fogger in his left hand and delivered a brief burst to the face of the female who put her hand out on him in an attempt to deter her hindrance of our arrest. MADDOX, who was also affected by residual spray from the MK-9 pepper fogger, was then removed from the crowd. As myself and several other KCPD officers attempted to place handcuffs on MADDOX, he continued to resist our efforts by tensing his arms and pulling them toward his side. After several minutes of MADDOX refusing to cooperate, the decision was made to stand MADDOX up without handcuffs in order to remove ourselves from the immediate area of the protest as water bottles were continually being thrown at us. MADDOX was then escorted away from the immediate area and placed in handcuffs without further incident. The female who had been sprayed with the MK-9 pepper fogger immediately retreated into the crowd and away from officers and was unable to be arrested for hindering.

As we were awaiting a patrol wagon to transport MADDOX, he advised me that he came to the protest with his 10 yr old son who was still in the crowd and wanted officers to contact him. As MADDOX was now being escorted by PO Whetro (TAC64), I went back to the area where MADDOX was arrested to contact his son but was unable to locate him. When I returned, EMS was ordered for MADDOX who stated he was going into cardiac arrest and was transported to Truman Medical Center. Due to this, I was unable to complete and issue his charge at that time.

UTT#200093046 for (70-73) Failure to Comply was completed and issued to MADDOX at a later date.

Remarks: Narrative:

On 05/30/2020 at approximately 1500 hours, I was working the police line during the Black Lives Matter protest at 47 St and J.C. Nichols. I observed MADDOX (ARR) walk to the front of the crowd. MADDOX began yelling and shouting at officers and inciting the other protesters. For approximately thirty minutes, I observed MADDOX walk out into the street multiple times so that he could yell at officers who were working the line. MADDOX was warned to stay out of the street numerous times. While I was observing MADDOX, he looked at me and stated, "when it gets dark we are going to burn this motherfucker down". A short time later, MADDOX walked out into the street again. Several officers moved forward to place MADDOX under arrest. I then observed multiple protesters holding onto MADDOX to prevent his arrest. Several unknown subjects also began throwing water bottles at officers while they were taking him into custody.
