COUNT 1: GRAND LARCENY ~ 21 O.S. § 1705, a FELONY

COUNT 2: COMPUTER FRAUD / UNLAWFUL USE OF COMPUTER / SYSTEM ~ 21 O.S. § 1953(A)(2),

STATE OF OKLAHOMA, COUNTY OF OTTAWA:

I, Kenny Wright, the undersigned District Attorney of said County, in the name and by the authority of the State of Oklahoma, give information that in said County of Ottawa and in the State of Oklahoma, **CLIFFORD ALBERT DEMOND** did then and there unlawfully, willfully, knowingly and wrongfully commit the crime(s) of:

COUNT 1: GRAND LARCENY ~ a FELONY, on or between the 23rd day of August, 2021 and the 12th day of September, 2021, by taking and carrying away by stealth money that belonged to Renee Haynes and was entrusted to the Ottawa County Sheriff's Office, without the consent of Renee Haynes, and with the intent to deprive Renee Haynes of the money permanently.

This crime is punishable by imprisonment in the State Penitentiary for a term of not more than five (5) years, or in the county jail for a term not to exceed one (1) year, by a fine not to exceed \$1,000.00, or by both such fine and imprisonment, and restitution.

COUNT 2: COMPUTER FRAUD / UNLAWFUL USE OF COMPUTER / SYSTEM ~ a FELONY, on or between the 23rd day of August, 2021 and the 12th day of September, 2021, by using a computer owned by the Ottawa County Sheriff's Office to devise or execute a login procedure to access an account with the intent to steal money from an inmate's account by means of a false or fraudulent representation.

This crime is punishable by imprisonment of 10 years and/or \$5000 to \$10,000 fine.
