I, S. Patterson, first duly sworn upon oath depose and state as follows, that I am a Special Agent with and for the Oklahoma Attorney Generals' Office and have so been since April 2014.

Between March 2015 and May 2015, the defendant, whom is the Sheriff of Love County Oklahoma willfully and knowingly, harbored Sara Bamburg and willfully maintained a dwelling where drugs are kept. At the time of the offense, Bamburg was avoiding arrest on felony arrest warrants issued in Carter County, Oklahoma for case CF-2013-647 (violation of felony probation), CF-2014-595 (false personation of another), and Love County case CF-2014-111 (knowingly concealing stolen property).

During the mentioned dates, Bamburg was in a relationship with the son of the defendant, identified as George William Russell. Bamburg was living at the residence of the defendant which is located at 27386 Deer Ridge Street, Leon Oklahoma, Love County Oklahoma, and during her time at the residence, she was assured by George William Russell that as long as she stayed at the residence, she would not be arrested on her outstanding warrant. Bamburg was assured by George William Russell that the defendant would be okay with her staying there and she would not be arrested as long as she was dating him. The defendant was identified as the owner of said residence through research via the Love County Oklahoma Assessor web page.

While living at the residence of the defendant, Bamburg observed George William Russell store methamphetamine for sale. Bamburg ~~described~~ ^{described} her and George William Russell speaking with the defendant while both she and George William Russell were high on methamphetamine. Bamburg states that the defendant gave the keys to his Love County Sheriff's Office patrol truck to George William Russell and allowed Russell to drive the vehicle. Bamburg states that while with George William Russell in the defendants patrol truck, George William Russell would sell methamphetamine. Bamburg further stated that she snorted a "line" of methamphetamine on the center console of the defendant's patrol truck.

Speaking with multiple sources of information (SOI), George William Russell was known as a dealer of methamphetamine in Love County. On multiple occasions dating back to 2011, individuals were at the residence of the defendant, which is located in Love County Oklahoma using methamphetamine while the defendant was present inside the residence.

Further, an SOI stated that at the direction of the defendant, he/she and George William Russell would go to locations to pick up methamphetamine for distribution. Upon picking up the methamphetamine, the SOI stated that the methamphetamine was brought back to the defendant's residence located in Love County.

In April 2015, Bamburg ceased dating George William Russell and left the residence as a result. Upon Bamburg leaving the defendants residence and moving into a new residence, Deputies from the Love County Sheriff's Office arrived at her new residence attempting to arrest her for her outstanding warrant. Avoiding arrest on 8 April 2015, Bamburg was finally arrested on 9 April 2015 by the defendant.

Upon the release of Bamburg from the Love County jail, a detention officer told Bamburg that the defendant had attempted to arrest her prior to her living at the defendant's residence with George William Russell.


In an interview conducted by the FBI, the detention officer stated to agents that the defendant instructed him/her and a Deputy to arrest Bamburg on 22 July 2014 because Bamburg had an active arrest warrant. The attempt to arrest Bamburg was unsuccessful.

The defendant is charged with the above mentioned crime(s).
