Upon Application for a Writ of Habeas Corpus Ad Testificandum filed in this Court by **E. SCOTT PRUITT**, the duly appointed, qualified and acting Attorney General for the State of Oklahoma, having duly considered the same on this 23rd day of January, 2017, and being otherwise well and duly informed in the premises and upon due consideration thereof, finds that the above-styled and numbered case, in which **DAVID R. WOLFE** is a witness, Case No. CF-2016-00194 is presently set for **PRELIMINARY HEARING on Monday, March 6, 2017, at 9:00 a.m.** and that said witness is now incarcerated in the custody of the Northeast Oklahoma Correctional Center, Vinita, Oklahoma, and that the Writ of Habeas Corpus Ad Testificandum

The Court, therefore, finds that Sheriff of Love County, State of Oklahoma, or other certified law enforcement officer, should be directed and authorized by this Court to proceed to the Northeast Oklahoma Correctional Center, Vinita, Oklahoma, there to receive from the said Northeast Oklahoma Correctional Center, the body of said witness, **DAVID R. WOLFE** and to return said witness to the County Jail of Love County, Marietta, Oklahoma, there to retain said witness pending and during this Preliminary Hearing.


