**FINAL ORDER OF REVOCATION**

The Council on Law Enforcement Education and Training (CLEET hereinafter), pursuant to 70 O.S. § 3311 and OAC Title 390 Chapter 2, does hereby enter this Final Order of Revocation in the above cause:

**FINDINGS OF FACT AND CONCLUSIONS OF LAW**

1. That Respondent is a certified Reserve Officer and Peace Officer in the State of Oklahoma.
2. That on or about February 20, 2020, Respondent was charged with one (1) count of Bringing Contraband (weapon) into penal institution, one (1) count of knowingly concealing stolen property, two (2) counts of Embezzlement and one (1) count of larceny of lost property in the District Court of Pittsburg County case CF-20-87.
3. That on or about April 22, 2022, Respondent entered a no contest plea to one (1) count of knowingly concealing stolen property, one (1) count of embezzlement and one (1) count of larceny of lost property and received a two (2) year deferred sentence for each charge to run concurrently in the District Court of Pittsburg County case CF-20-87.
4. That pursuant to 70 O.S. § 3311, "The Council shall revoke the certification of any person upon determining that such person has been convicted of a felony or a crime involving moral turpitude or a domestic violence offense or has entered a plea of guilty, or nolo contendere or an "Alford" plea or any plea other than a not guilty plea for a felony offense, a crime of moral turpitude or a crime of domestic violence or is the respondent in a final Victims Protective Order. . . ."
5. That pursuant to 70 O.S. § 3311, "The Council shall revoke the certification of any person upon determining that such person has received a deferred sentence for a felony, a crime involving moral turpitude or a domestic violence offense."
6. That Notice of Intent to Revoke was mailed via certified, return-receipt requested, tracking number 70192280000204502442, on July 6, 2022, to Respondent at his or her address on file with CLEET.
7. That on or about July 9, 2022, CLEET received the signed green card corresponding with certified mail tracking number 70192280000204502442.
8. That no request for hearing has been received pursuant to OAC Title 390 Chapter 2.
9. That Notice is deemed properly served.


**DISPOSITION**
