Facts & Circumstance that support probable cause to arrest the above named person are

I, Deputy Joseph L. Schanz, am a Deputy Sheriff with the Johnston County Sheriff's Office. I hold valid cross-commissions with both the Chickasaw Nation Lighthorse Police, as well as the Choctaw Nation Tribal Police. Also, I hold a valid Special Law Enforcement Commission (SLEC) through the Bureau of Indian Affairs (B.I.A.). I attest that the below report is true and correct to the best of my knowledge:

On 01/13/2022 at approximately 2200 hours, I was patrolling highway 22 between Tishomingo and Ravia. As I passed the Rock Creek RV park, I observed an older model silver SUV idling beside a camper. This area is known to me as a high crime area, due to the multitude of arrests I have made for drug offenses, felons in possession of firearms, and multiple fugitives who have had felony warrants. I then waited on highway 22 on the shoulder for the vehicle to leave and I then followed it into Tishomingo in an attempt to find probable cause to perform a traffic stop. The Gray Toyota SUV was bearing the Chickasaw Nation License Plate CN48386. Deputy Ty Richeson was waiting at the Y intersection on highway 22 and highway 377 and then proceeded to follow behind me.

I was unable to gain cause to perform a traffic stop and the subject pulled into the west side EZ Mart in Tishomingo. I then went to sit in the Tishomingo Lumber Yard parking lot and wait for them to leave again. At this time, Deputy Richeson pulled up beside me and I asked him if he would drive to the EZ Mart and see if the subject's front windshield was cracked. His windshield was in fact cracked, and I waited for him to leave the parking lot to initiate a traffic stop based on that traffic violation. As he left the parking lot, he engaged his left turn signal, however continued north onto Broadway. I then got behind the vehicle once more and initiated my emergency lights to perform a traffic stop around Broadway and 9th street.

This subject (who I will identify now as Mark Crawley, Date of Birth 02/17/1988, Non Native. However at the time, I did not know who was operating the vehicle) then accelerated and gave chase. The pursuit reached approximately 40-50 mile per hour as we approached the Tishomingo Elementary School. We then went west on 4th Street and he immediately turned into North Broadway once again and accelerated again to 50 miles per hour through residential streets, completely disregarding the safety of homeowners.

We then turned east onto Morrow Road where Crawley stopped at 118 E Morrow, the location that was later discovered to be his address listed on his flagged drivers license. Crawley had yelled something unintelligible at me as I drew my service pistol and ordered him out of the vehicle. He then accelerated again and the chase continued.

We reached an open field where Crawley went into the pasture at a high rate of speed, and then doubled back towards Morrow. I attempted to cut off Crawley at this point, however he was coming straight for me in his vehicle. I then drew my service pistol with the intention of using lethal force against Crawley to preserve my life, and prevent Crawley from causing serious injury to the law enforcement personnel behind me who were also in pursuit. Crawley however decided to stop his vehicle prior to hitting me and attempted to go around me. I had attempted to accelerate and cut him off once more but was unsuccessful, and he collided with Tishomingo Police Officer Jonah Wiss and began driving at a high rate of speed towards Kemp.

Deputy Richeson was behind Crawley at this point and struck the rear end of Crawley's vehicle due to Crawley slamming on his brakes. As we pursued Crawley as he went north out of Tishomingo, we reached speeds up to 100 miles per hour leaving Tishomingo city limits. We then went approximately 2 miles north of Tishomingo and then Crawley began slamming on his brakes in an attempt to get Deputy Richeson to wreck. He then turned into a driveway and rammed a closed gate with his vehicle and began to drive through another pasture. Crawley was attempting to turn left towards other law enforcement personnel and I once again perceived this as Crawley attempting to weaponize his vehicle and use it to ram another law enforcement officer. Seeing as how he already collided with Officer Wiss, attempting to hit me with his vehicle on Morrow, and the complete disregard for public safety and the safety of other law enforcement officers, I once again was preparing to use lethal force against Crawley if he began to accelerate towards any officer on scene.

As Crawley was turning left, Deputy Richeson used his patrol vehicle and struck Crawley on the rear bumper which caused Crawley to roll his vehicle over and also disabled it from being used against anyone else.

I then left my patrol unit along with Deputy Ty Richeson, and Deputy Justin Murray. We then approached the vehicle with weapons drawn and ordered Crawley out of the vehicle. He was refusing to comply so I was then forced to kick out the rest of the windshield and crawl into the vehicle from the windshield, and physically drag Crawley out of the vehicle through the shattered windshield with the help of Deputy Richeson.

Once Crawley was dragged from the vehicle he still refused to give us his hands for us to place them into handcuffs. I then delivered a closed fist strike to Crawley's abdomen. Crawley was attempting to roll over onto his back and struck him once more in the jaw with a closed fist. Crawley was still resisting and refusing to listen to orders so I got into a full back mount, and placed him in a carotid restraint, but did not apply the needed pressure to render him unconscious. I did this in order to prevent Crawley from resisting any further and causing more injuries to myself, the other deputies and law enforcement officers, and himself. This was successful and we were then able to place both hands into handcuffs and escorted him to my patrol unit.

I sustained various scratches and abrasions from having to kick out the windshield and drag Crawley through it. The majority of these cuts were on my right hand and left knee. My glasses were also broken during this scuffle.

Deputy Richeson sustained injuries to his hands as well from the altercation.

Deputy Murray also sustained injuries to his hands during the altercation.

EMS personnel arrived on scene and treated Crawley for his injuries.

Crawley was under the influence of methamphetamine during this pursuit. He told Sheriff Gary Dodd that he uses a crumb of methamphetamine (approximately .2 grams of meth) everyday. 2 methamphetamine pipes were also located at the scene of the wreck.

Crawley is also a wanted fugitive out of multiple counties for a litany of felonies. Out of Pittsburg County, he was wanted for a revocation of a suspended sentence. In McIntosh County under an alias of Kyle Crawley, he was wanted for escape from arrest or detention.

According to the department of correction's inmate look up. Crawley has been processed for a multitude of violent crimes such as Kidnapping, and multiple Counts of Assault and Battery with a Dangerous Weapon. He has also been processed for escaping arrest, possession of methamphetamine, and providing false information.

Crawley was read the implied consent in the jail, and initially agreed to take the test. He then later refused the test prior to departing from the jail. He was then placed back into an observation cell where I instructed the jailers to do 15 minute checks on him due to the head injuries he sustained.

Mark K. Crawley is currently incarcerated in the Johnston County Jail for the following offenses

Assault and Battery on a Peace Officer with Dangerous Weapon X3 - For the attempt to hit me, Deputy Schanz, head on with his vehicle. For successfully having a collision with Officer Wiss. For continuing to slam his brakes causing Deputy Richeson to rear end him on Morrrow Road, and for slamming his brakes at 100 miles per hour in an attempt to get Deputy Richeson to wreck on Kemp and also on North 377

Felony Eluding - For the complete disregard for public safety due to attempting to flee at a high rate of speed while in a residential area and an elementary school at a high rate of speed

Driving Under the Influence of Drugs (Methamphetamine) - Per his admission of smoking methamphetamine everyday, due to his reckless driving behavior, and the physical signs he was showing

Possession of CDS Methamphetamine - For having Methamphetamine residue on the 2 Methamphetamine Pipes located at the scene of the crash

Possession of Drug Paraphernalia - For being in Possession of 2 Methamphetamine Pipes

Malicious Injury to Property Under \$1,000 dollars - For ramming the property owners locked cattle gate

Obstruction of an Officer - For refusing to pull over as I initiated my traffic stop. For stopping once momentarily then taking off once again.

Resisting Arrest - For refusing to pull over and resisting myself, Deputy Richeson, and Deputy Murray as we attempted to arrest Crawley

D.U.S. - For driving while Flagged

Operating a Vehicle with a Cracked Windshield - For operating a motor vehicle with a cracked windshield
