AFFIDAVIT FOR DETENTION AFTER ARREST

State of Oklahoma,)
County of Johnston)

Ashley Hanks, of lawful age and being first duly sworn, deposes and says:

Your affiant is Ashley Hanks with the Tishomingo Police Department.

That on the 3rd day of September 2022 at 21:25 o'clock p.m. your affiant, Ashley Hanks, Tishomingo Police Department made a warrantless arrest of the following person Randy Lee Newton, white male, date of birth [REDACTED] 1981 for the offense of,

**Domestic Violence in Presence of a Minor
Domestic Violence by Strangulation**

and said person is presently in custody at the Johnston County Jail.

That the facts and circumstances for which this arrest was made are as follows, to-wit:

On September 3, 2022 approximately 1917 hours I was notified through the Johnston County Dispatch of a domestic located at [REDACTED] in the city limits of Tishomingo. The reporting party (Shannon Hughes) stated that it was physical, and the other party (Randy Newton) was still currently on scene. At 1918 Shannon stated to 911 that she did not want anyone to respond that Randy had stopped, and she would call back if it occurred again. Shortly after myself and Deputy Justin Murray arrived on scene.

Upon arrival I was met with several family friends outside that stated they were not on scene when everything happened. Once I knocked at the door announcing myself as with the Tishomingo Police Department [REDACTED] (date of birth [REDACTED]/2006) answered and a few moments later his mother Shannon (date of birth [REDACTED]/1981) stepped out. Shannon stated that her and her daughter Makayla Hughes (date of birth [REDACTED]/2000) got into a physical altercation about an hour before we arrived. I asked Shannon why she called the cops saying Randy was being physical and she stated that he did throw items in the house, but not at her and he stopped. Shannon was extremely uncooperative and refusing to answer several questions. Shannon then stepped inside the residence to get Randy after I stated to her that I would go inside the house myself to get him if he did not come to the door. The son [REDACTED] then stated to me that Randy was outside in the backyard, I then walk around the house and do not locate him. Walking back to the door I then ask [REDACTED] his name and date of birth and he stated he did witness everything but was hesitant to say much of anything else, but he did indicate that Randy choked her.

Randy then walked outside, and I pulled him to the side alone. Randy stated that he did not witness the altercation with Makayla since he was asleep at that time. He did admit that Shannon and him got into an altercation, but he was not physical with her and all of the marks on her face and neck were from Makayla and he did not want to answer further. At this time Deputy Murray left the scene and Officer Isiah Stowe arrived. I then documented the physical evidence on my work phone.

At this time, I requested that DHS contact me and asked for a joint response. As I was waiting for DHS to arrive, I received a phone call from the party's family friend, Joshua Paul, who stated that Makayla admitted to him that they did have a physical altercation earlier, and she planned to turn herself in at the Johnston County Sheriff's office later that night. I then notified dispatch that Makayla would be arriving there later and to contact me once she did. I then attempted to speak with Shannon about what occurred with Makayla, and she stated that she did not want to pursue charges and refused to answer any more questions yelling she should have just lied to begin with and told her son [REDACTED] not to say anything to us.

I then let Shannon cool off as she was pacing and still yelling in the yard and went to speak with the family friend that spoke to me as I first arrived. Terry Hughes [REDACTED] (older brother) stated that he was there to pick up [REDACTED]. I have attached a screenshot between Terry and [REDACTED] stating that "Randy choked out" Shannon. I advised Terry that DHS has been contacted since [REDACTED] is a minor and soon as DHS gets here and approves that [REDACTED] is good to leave, they can go. Terry then left for the time being.

Approximately 2030 hours DHS arrived on scene. At this time Shannon had cooled off and began discussing the altercation with Makayla. She stated that Makayla came over mad [REDACTED] their cell phones being shut off and she had accused her of stealing her cell phone. Shannon stated that Makayla then went into her bedroom and began looking through her nightstand. Shannon stated they began arguing and she pushed Makayla out of the bedroom and Makayla struck her in the face and scratched her neck. She stated that Makayla then left the house, and she was already in a bad mood so her and Randy began to argue but would not be specific about it. She stated that Randy threw a few things, but that was it before the cops arrived.

At approximately 2100 Officer Stowe arrived to speak with Makayla at the Sheriff's office as I stayed on scene with DHS. Officer Stowe stated that Makayla was sitting on a bench, and she immediately said that she did strike her mother Shannon in the face. Makayla filled out a statement saying that her mother Shannon had her cell phone so as she went to look for it and Shannon shoved her against the wall and struck her 3 different times all in front of [REDACTED]. She stated that after that she then struck her back in the face near her left eye, but not near her throat. Officer Stowe then placed her under arrest for Domestic violence in presence of a minor and escorted her to the jail.

At 2115 Officer Stowe then arrives back to the scene with me and I read Randy Newton the Miranda warning. Randy stated that he did not do anything but based on the physical evidence presented he was placed under arrest for Domestic violence by strangulation and domestic violence in the presence of a minor and Officer Stowe then transported him to the

Johnston County Jail. Randy yelled several times to Shannon stating that "Makayia needs her bitch ass beat." [redacted] then left the property with his brother Terry (jr) and their father Terry. Shannon would not provide his home address or his phone number but provided us with Terry jr's phone number which is [redacted]

At this point I went back to Shannon to ask if she had anything else to add. To which she admitted to lying about Randy not choking her. Shannon refused to say anything else involving Randy. I then read the Domestic Lethality form to which she agreed to answer and left Shannon a safe-line packet and have attached her answers to this report. I then left Shannon a statement form to fill out, which she has declined to turn in. Shannon has been extremely uncooperative during the investigations to both domestic situations that occurred today. Shannon then stated that she cannot get in trouble as she is a DHS worker herself even though she knows she has lied tonight both to myself and DHS.

Based upon the above, your affiant prays this court issue a finding of fact that probable cause exists to believe that the named defendant committed the offense of

Domestic Violence in Presence of a Minor
Domestic Violence by Strangulation

and that the named defendant should be held and detained to answer therefore.
