FINAL ORDER OF REVOCATION

The Council on Law Enforcement Education and Training (CLEET hereinafter), pursuant to 70 O.S. § 3311 and OAC Title 390 Chapter 2, does hereby enter this Final Order of Revocation in the above cause:

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. That Respondent is a certified Peace Officer and Self Defense Act Instructor in the State of Oklahoma.
- 2. That on or about December 05, 2017, Respondent was charged with one (1) count of Murder in the Second Degree in violation of 21 O.S. § 701.8 or in the alternative one (1) count of Manslaughter in the First Degree in violation of 21 O.S. §711(3) in the District Court of Oklahoma County case no. CF-2017-7236.
- 3. That on or about December 19, 2019, Respondent was found guilty of one (1) count of Murder in the Second Degree in violation of 21 O.S. § 701.8 and received a ten (10) year sentence in the District Court of Oklahoma County case no. CF-2017-7236.
- 4. That Murder in the Second Degree is a felony.
- 5. That on or about April 28, 2022, Mandate was issued in the Court of Criminal Appeals of the State of Oklahoma case F-2020-5 Affirming the decision of the District Court of Oklahoma County case no. CF-17-7236.
- 6. That on or about July 08, 2021, Respondent was charged with twelve (12) counts of possession of child pornography in violation of 21 O.S. § 1024.2 in the District Court of Marshall County case no. CF-21-119.
- 7. That on or about September 23, 2021, CLEET issued a notice of summary suspension in this case and said suspension remains currently in effect.
- 8. That Marshall County case no. CF-21-119 is still pending.
- 9. That pursuant to 70 OS 3311, "The Council shall revoke the certification of any person upon determining that such person has been convicted of a felony or a crime involving moral turpitude or a domestic violence offense or has entered a plea of guilty, or nolo contendere or an "Alford" plea or any plea other than a not guilty plea for a felony offense,

- a crime of moral turpitude or a crime of domestic violence or is the respondent in a final Victims Protective Order. . ."
- 10. That pursuant to 70 OS 3311, "The Council shall revoke the certification of any person upon determining that such person has received a deferred sentence for a felony, a crime involving moral turpitude or a domestic violence offense."
- 11. - 14. That on or about September 23, 2021, CLEET received the signed green card corresponding with certified mail tracking number 7020 2450 0000 1391 3814.
- 15. That no request for hearing has been received pursuant to OAC Title 390 Chapter 2.
