FINAL ORDER OF REINSTATEMENT

The Council on Law Enforcement Education and Training (CLEET hereinafter) and, pursuant to the Administrative Procedures Act, 75 O.S. Section 250, et seq., does hereby enter its final order on the above cause:

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. That Respondent was mailed a Notice of Intent to Suspend Peace Officer/Reserve Officer Certification.
2. That Respondent was given notice pursuant to 70 O.S. §3311.4(E) of his/her failure to meet the minimum continuing education requirements provided in 70 OS § 3311, 70 OS § 3311.4, and 70 OS §3311.5.
3. That he/she did not provide evidence of compliance with statutory continuing education requirements by December 31, 2019 and did not request an administrative hearing.
4. That a Final Order of Suspension was issued suspending the peace officer certification of Respondent.
5. That CLEET has been provided satisfactory evidence of compliance with the provisions of 70 OS § 3311, 70 OS § 3311.4, 70 OS §3311.5, and Rule 390:10-1-7, and Respondent is entitled to reinstatement of his/her Peace Officer/Reserve Officer certification.
6. That CLEET has the authority to promulgate Rules pursuant to 70 OS § 3311 et seq.
7. That Respondent has satisfied the requirements of 70 OS § 3311, 70 OS § 3311.4, and 70 OS §3311.5 relating to continuing education for certified Peace Officers and Reserve Officers.
8. That CLEET is satisfied that Respondent has complied with the reinstatement process.
9. That Respondent is entitled under the law to reinstatement of his/her Peace Officer/Reserve Officer Certification.
10. That all procedural requirements relative to the administrative hearing, notices, and due process, have been satisfied.


DISPOSITION

It is further ordered that a copy of this Reinstatement Order be placed in the officer's file and CLEET records be modified to reflect that Respondent is a certified Peace Officer and/or Reserve Officer in Oklahoma.


