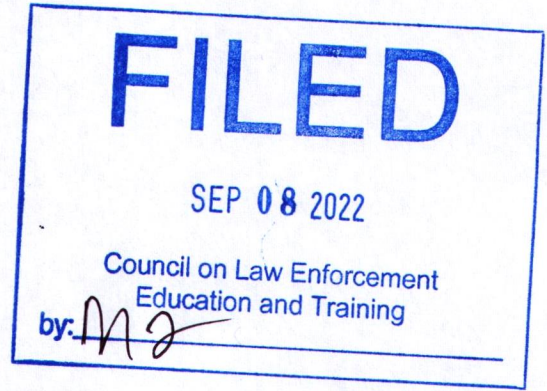

FINAL ORDER OF ADMINISTRATIVE FINE

The Council on Law Enforcement Education and Training (CLEET hereinafter), pursuant to 70 O.S. § 3311, 59 OS § 1750.1 et al and Rule 390:2-1-2, does hereby enter this Final Order of Administrative Fines in the above cause:

FINDING(S) OF FACT AND CONCLUSION(S) OF LAW

1. That an investigation performed by CLEET Investigator Tami Terneus determined that the following as occurred:
 - a. That Respondent has been holding himself out as an armed security guard and contracting with employers to provide armed security guard services.
 - b. That Respondent does not have a current armed security guard license or any other current license through CLEET.
 - c. That Respondent identifies himself as owning and operating T.R.B. Security & Investigation.
 - d. That T.R.B. Security & Investigation is not a licensed security guard or private investigative agency.
2. That the total fines to be assessed are as follows:
 - a. Impersonating a licensed security guard-\$500
 - b. Operating an unlicensed security or investigative agency-\$2,000
 - c. Operating an improperly marked security vehicle-\$150
3. That Notice of Administrative Fines was mailed via certified, return-receipt requested, restricted delivery on June 14, 2022, to Respondent at the address of record.
4. That on or about June 24, 2022, CLEET received the return-receipt card that was signed by Respondent on June 18, 2022.
5. That Notice of Administrative Fines is deemed legally served.
6. That no request for hearing has been received pursuant to CLEET Rule 390:2-1-2(c)(3)(B).

7. That no payment on the above-mentioned fines has been received.
8. That CLEET has the authority to promulgate the rules and take disciplinary actions involving individuals and agencies with security guard and private investor licenses pursuant to 59 O.S. § 1750 *et seq.*


DISPOSITION

1. That the administrative penalty for a first offense of impersonating a licensed security guard is a fine of \$500.00 and is SUSTAINED.
2. That the administrative penalty for a first offense of operating an unlicensed security or investigative agency is a fine of \$2,000.00 and is SUSTAINED.
3. That the administrative penalty for a first offense of operating an improperly marked security vehicle is a fine of \$150.00 and is SUSTAINED.
4. The total fine of two thousand six hundred fifty dollars and no cents (\$2,650.00) is due and owed to CLEET.



NOTIFICATION OF APPEAL RIGHTS

If an application for rehearing is not filed, you are entitled to judicial review by filing a petition for review in the District Court within thirty (30) days after you are notified of this determination, 75 O.S. §318. Copies of such petition shall be served upon this agency within ten (10) days after filing such petition.
