The undersigned upon oath deposes and states as follows, to wit:

Affiant advises that on the 12 day of November 2017 at approximately 2138 hours, the following

incidents occurred at the intersection of E 273<sup>rd</sup> S and S 95<sup>th</sup> E in Porum, OK

Muskogee County, Oklahoma.

On 12 NOV 17 at approximately 2140 hours I observed a Dodge pickup displaying Oklahoma tag 418 HJQ traveling Eastbound on E 273rd ST S about E 93rd ST S. I observed that the vehicle had and inoperable tag light and the driver failed to maintain his lane crossing the center line several times as well as the fog line.

I initiated a traffic stop on the vehicle and made contact with driver Donald Fools. Upon making contact with Mr. Fools I could smell the odor of alcoholic beverage emitting from the vehicle. Mr. Fools had slow slurred speech, and once he exited the vehicle he was unsteady on his feet. Mr. Fools stated that he had drank a twelve pack or more of beer. Upon further investigation and standardized field sobriety testing it was determined that Mr. Fools was under the influence of alcohol. Mr. Fools was arrested for driving under the influence, and transported to Muskogee County Detention Center with no further incident.

Mr. Fools agreed to take the states test, but refused testing upon arrival to the hospital.
