FINAL ORDER OF REVOCATION

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. That Respondent is a certified Peace Officer in the State of Oklahoma.
- 2. That on or about November 14, 2017, Respondent was charged with Driving a Motor Vehicle While Under the Influence of Alcohol (a felony) in the District Court of Muskogee County case CF-17-1162.
- 3. That on or about August 16, 2018, Respondent entered a plea of nolo contendere to Driving a Motor Vehicle While Under the Influence of Alcohol in violation of 47 O.S. § 11-902(A)(2) and received a five (5) year deferred sentence in the District Court of Muskogee County case CF-17-1162.
- 4. That driving a motor vehicle while under the influence is a crime of moral turpitude.
- 5. That pursuant to 70 OS 3311, "The Council shall revoke the certification of any person upon determining that such person has been convicted of a felony or a crime involving moral turpitude or a domestic violence offense or has entered a plea of guilty, or nolo contendere or an "Alford" plea or any plea other than a not guilty plea for a felony offense, a crime of moral turpitude or a crime of domestic violence or is the respondent in a final Victims Protective Order. . ."
- 6. That pursuant to 70 OS 3311, "The Council shall revoke the certification of any person upon determining that such person has received a deferred sentence for a felony, a crime involving moral turpitude or a domestic violence offense."
- 7. That Notice of Intent to Revoke was mailed via certified, return-receipt requested, tracking number 7019 2280 0002 0450 2428, on July 6, 2022, to Respondent at his or her address on file with CLEET.
