FINAL ORDER OF SUSPENSION

The Council On Law Enforcement Education and Training (CLEET hereinafter), pursuant to 70 O.S. § 3311 and Rule 390:2-1-2, does hereby enter this Final Order of Suspension in the above cause:

FINDING OF FACT(S)

- 1. That Respondent is a certified Peace Officer and/or Reserve Officer in the state of Oklahoma.
- 2. That pursuant to 70 O.S., § 3311 and CLEET Rule 390:27-1-2, Respondent must meet the annual Firearms Regularification requirement.
- 3. That Pursuant to 70 O.S. § 3311.4(A), Respondent, (if certified full-time and having been commissioned more than 90 days in the year 2019 as a full-time officer or combination of full-time and reserve officer), is required to have 25 hours of continuing law enforcement training accredited or provided by CLEET. At least two (2) of the 25 hours of continuing education must be on mental health issues and be accredited for mental health credit, (mental health hours are included in the total hours).
- 4. That pursuant to 70 O.S. § 3311.5(C) Respondent, (if certified full-time and having been commissioned more than 90 days in the year 2019 as a full-time officer or combination of full-time and reserve officer), must have completed evidence-based sexual assault and sexual violence training, (EBSA).
- 5. That Pursuant to 70 O.S. § 3311.4(B), Respondent, (if having been commissioned more than 90 days in the year 2019 as a reserve officer), is required to have eight (8) hours of continuing law enforcement training accredited or provided by CLEET. At least one (1) of the eight (8) hours of continuing education must be on mental health issues and be accredited for mental health credit, (mental health hours are included in the total hours).
- 6. That all continuing education and training requirements for the year 2019 must have been completed by December 31, 2019.
- 7. That pursuant to 70 OS § 3311.4(E), "Any active full-time or reserve certified peace officer, or CLEET-certified cross-deputized tribal officer who fails to meet the annual training requirements specified in this section, shall be subject to having the certification of the peace officer suspended..."

- 8. That pursuant Rule 390:27-1-6, "Failure to meet the annual requalification requirements shall subject the officer to disciplinary action in accordance with OAC 390:2."
- 9. That Respondent has not met one or more of the above mentioned continuing education and training requirements for the year 2019 and is therefore, subject to having his/her peace officer and/or reserve officer certification suspended.
- 10. Pursuant to 70 O.S. § 3311(J)(10)(c), "... Any person whose certification has been revoked, suspended or voluntarily surrendered for any reason, including failure to comply with mandatory education and training requirements, shall pay a reinstatement fee of One Hundred Fifty Dollars (\$150.00)."

CONCLUSION OF LAW(S)

- 1. That CLEET has the authority to promulgate Rules pursuant to Title 70 OS § 3311 et seq.
- 2. That Respondent has acknowledged receipt of Notice of Intent to Suspend and/or an Affidavit of Service was provided to CLEET.
- 3. That Respondent has not met one or more of the continuing education and training requirements for the year 2019 and is therefore, subject to having his/her peace officer and/or reserve officer certification suspended.

DISPOSITION

The Respondent's CLEET certification(s) is/are hereby suspended in accordance with CLEET Rule 390:2-1-2 and pursuant to 70 O.S. § 3311.4.
