<u>DEFAULT FINAL ORDER OF REVOCATION AND</u> <u>FINAL ORDER OF ADMINISTRATIVE FINES</u>

The Council on Law Enforcement Education and Training (CLEET hereinafter), pursuant to 59 OS § 1750.1 et al and Rule 390:2-1-2, does hereby enter this Final Order of Revocation and Final Order of Administrative Fines in the above cause:

FINDING(S) OF FACT(S) AND CONCLUSIONS OF LAW

- 1. That Respondent is a licensed unarmed security guard in the state of Oklahoma.
- 2. That on or about July 19, 2022, a petition for protective order was filed against Respondent in case no PO-22-1573 within the OK. County District Court.
- 3. That on or about July 6, 2022, an emergency order of protection was filed against Respondent in case no PO-21-56 within the OK County District Court.
- 4. That on or about July 19, 2022, a final order of protection was issued against Respondent in the above-mentioned matter.
- 5. That pursuant to CLEET Rules, Chapter 35, Appendix A, Entry of a final order of protection against an applicant or licensee is a disqualifier and "may disqualify a person from obtaining or holding an unarmed or armed security guard license or private investigator license."
- 6. That Respondent failed to notify CLEET of said proceedings as required pursuant to OAC 390:35-9-4.
- 7. That pursuant to CLEET Rule 390:35 Appendix 'D', the fine for a first-time offense of 'Failure to Report Protective Order-General Civil Penalty' is \$50.00.
- 8. That CLEET has the authority to promulgate rules and pursue disciplinary actions against Private Security guards pursuant to 59 O.S. § 1750 et seq.
- 9. That Notice of Intent to Revoke and Notice of Administrative Fines was mailed via certified, return-receipt requested, restricted delivery, tracking number 7020 0640 0001 4676 1617 on August 31, 2022, to Respondent's address of record.
- 10. That on or about September 14, 2022, CLEET received the signed green card corresponding with certified mail tracking number 7020 0640 0001 4676 1617.
- 11. That on or about September 20, 2022, CLEET received a written request for hearing.
- 12. That on or about September 20, 2022, Notice and Order Setting Hearing was filed, and a copy mailed to Respondent at his address on file with CLEET.
- 13. That a hearing was set for October 14, 2022, at 10:00 am.

14. That on October 14, 2022, at 10:00 am, Respondent did not appear for the above-mentioned hearing.

DISPOSITION

- 1. The Respondent's CLEET license is hereby revoked in accordance with CLEET Rule 390:2-1-2 and pursuant to 59 O.S. § 1750.7.
- 2. The fine for a first-time offense of 'Failure to Report Protective Order-General Civil Penalty' is \$50.00 and said fine is owed and due to CLEET.
