FINAL ORDER OF SUSPENSION

The Council on Law Enforcement Education and Training (CLEET hereinafter), pursuant to 70 O.S. § 3311 and OAC Title 390 Chapter 2, does hereby enter this Final Order of Suspension in the above cause:

FINDING OF FACT AND CONCLUSIONS OF LAW

1. That Respondent is a certified Reserve Peace Officer in the State of Oklahoma.
2. That on or about July 26, 2019, a Final Order of Suspension was entered against Respondent in case 148244-19 due to failure to meet the statutory continuing education requirements for the calendar year 2018.
3. That at the time of the suspension, Respondent was not commissioned.
4. That a copy of the Final Order of Suspension was mailed to Respondent at his address of record, Oklahoma County Sheriff's Office, Oklahoma County DA, and the liability insurance company of the law enforcement agency that employed the peace officer, pursuant to 70 OS § 3311.4.
5. That on or about April 20, 2021, Respondent became commissioned by McCloud Police Department.
6. That on or about January 24, 2022, a Final Order of Reinstatement was filed in case 148244-19.
7. That on or about December 30, 2021, CLEET received a statement from McCloud PD Assistant Chief Kyle Webb advising that Respondent was actively working as a Reserve Officer during which time Respondent's certification was suspended.
8. That working while suspended is a violation of statute and rules.
9. That CLEET has the authority to promulgate the rules and take disciplinary actions involving individuals with peace officer certifications pursuant to 70 OS § 3311.
10. That Respondent knowingly worked while his CLEET certification was suspended and therefore, pursuant to 70 OS § 3311.4 and Rule 390:10-1-7(b)(1) his CLEET certification should be suspended.
11. That on or about February 11, 2022, Notice of Intent to Suspend was filed and mailed to Respondent by certified, restricted delivery, return receipt requested, tracking number 7019 2280 0002 0450 0158.
12. That on or about April 04, 2022, CLEET received the mailing back corresponding with certified mail tracking number 7019 2280 0002 0450 0158 "RETURN TO SENDER UNCLAIMED UNABLE TO FORWARD".
13. That no request for hearing has been received pursuant to OAC Title 390 Chapter 2.
14. That Notice is deemed properly served.
15. That CLEET has the authority to promulgate Rules pursuant to Title 70 Section 3311.

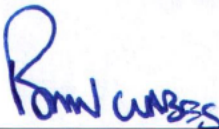
DISPOSITION

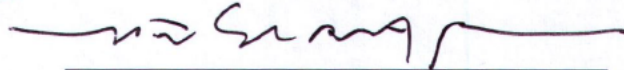

NOTIFICATION OF APPEAL RIGHTS

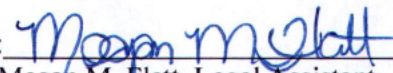
