STATE OF OKLAHOMA, COUNTY OF CARTER:

I, Craig Ladd, the undersigned District Attorney of said County, in the name and by the authority of the State of Oklahoma, give information that in said County of Carter and in the State of Oklahoma, **TYLER DALE SKINNER** did then and there unlawfully, willfully, knowingly and wrongfully commit the crime(s) of:

COUNT 1: MALICIOUS INJURY TO PROPERTY - UNDER \$1000 ~ a MISDEMEANOR, on or about the 20th day of February, 2022, by maliciously damaging his ballistic vest that belonged to the City of Wilson, Wilson, Carter County, Oklahoma, by firing a pistol at his vest, with a value of less than \$1,000.00, contrary to the form of the statute in such cases made and provided, and against the peace and dignity of the State of Oklahoma.

This crime is punishable by a fine of up to \$500 or imprisonment in the county jail for up to one year, or both.

COUNT 2: MALICIOUS INJURY TO PROPERTY - UNDER \$1000 ~ a MISDEMEANOR, on or about the 20th day of February, 2022, by maliciously damaging a handcuff case that belonged to the City of Wilson, Wilson, Carter County, Oklahoma, by firing a pistol at his ballistic vest causing a projectile from said weapon to strike his handcuff case, with a value of less than \$1,000.00, contrary to the form of the statute in such cases made and provided, and against the peace and dignity of the State of Oklahoma.

This crime is punishable by a fine of up to \$500 or imprisonment in the county jail for up to one year, or both.

COUNT 3: FALSE REPORTING OF CRIME ~ a MISDEMEANOR, on or about the 20th day of February, 2022, by unlawfully, willfully, knowingly and without probable cause make a false report to one Tucker Halstied, a Deputy with the Carter County Sheriff's Department, in Carter County, State of Oklahoma, of circumstances indicating the possibility of a crime having been committed: that is to say, said defendant reported that an unidentified person fired a black pistol at him, which report was false, and which said defendant gave then and there willfully, knowingly and without probable cause of the truth thereof, and which false report caused or encouraged the exertion of police action and investigation thereof, contrary to the form of the statute in such cases made and provided, and against the peace and dignity of the State of Oklahoma.

This crime is punishable by up to 90 days in jail and or up to a fine of \$500.

COUNT 4: FALSE REPORTING OF CRIME ~ a MISDEMEANOR, on or about the 22nd day of February, 2022, by unlawfully, willfully, knowingly and without probable cause make a false report to one Justin Brown, an Investigation Agent with the Oklahoma State Bureau of Investigation, of circumstances indicating the possibility of a crime having been committed: that is to say, said defendant reported that an unidentified person fired a black pistol at him, which report was false, and which said defendant gave then and there willfully, knowingly and without probable cause of the truth thereof, and which false report caused or encouraged the exertion of police action and investigation thereof, contrary to the form of the statute in such cases made and provided, and against the peace and dignity of the State of Oklahoma.

This crime is punishable by up to 90 days in jail and or up to a fine of \$500.
