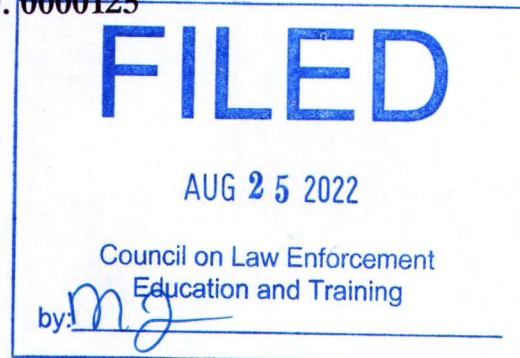

AGREED FINAL ORDER OF WITHDRAWAL AND SURRENDER

The Council on Law Enforcement Education and Training (CLEET hereinafter) and Respondent, pursuant to Rule 390:10-1-7, do hereby enter this agreed to final order of withdrawal and surrender:

FINDING(S) OF FACT:

1. That Respondent has requested a waiver of a portion of his promissory note related to basic peace officer certification.
2. That Respondent has agreed to pay to CLEET the amount of \$1,411.00, which is 2/3 of the amount owed on his promissory note. Such amount will be paid as follows: (1) one lump sum of \$1,000.00 within 30 days from the date CLEET and Respondent agreed to the settlement and (2) \$411.00 to be paid out monthly in payments of no less than \$25.00 beginning no later than October 1, 2022.
3. That Respondent's financial circumstances combined with the agreed payments above are found to be good cause for forgiveness of the remaining \$711.00 of Respondent's obligation, provided Respondent voluntarily and permanently withdraws and surrenders his peace officer certification, waives any rights to appeal this final order, and agrees not to request or otherwise seek reinstatement of peace officer or reserve peace officer certification in the future except upon payment of the \$711.00 forgiven by CLEET.
4. That Respondent's withdrawal of certification should be accepted.

CONCLUSIONS OF LAW:

That Respondent's voluntary withdrawal and surrender of his CLEET certification should be accepted.

DISPOSITION:


Respondent's certification is considered withdrawn and surrendered and Respondent waives any rights to appeal this final order and agrees not to request reinstatement of peace officer or reserve peace officer certification in the future except under circumstances outlined above.





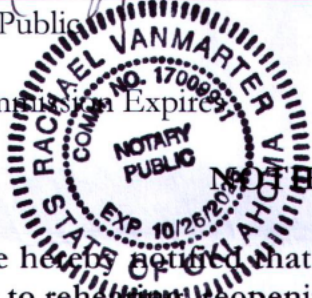

NOTIFICATION OF APPEAL RIGHTS

You are hereby notified that any determination in an individual proceeding shall be subject to rehearing, reopening, or reconsideration by the agency within ten (10) days of its entry, 75 O.S. § 317. If an application for rehearing is not filed, you are entitled to judicial review by filing a petition or review in the District Court within thirty (30) days after you are notified of this determination, 75 O.S. § 318. Copies of such petition shall be served upon this agency within ten days after filing such petition.
