## ILLEGAL BUGGING OF CARTER COUNTY JAIL ATTORNEY ROOM

I recently learned that an employee at the Carter County Jail identified a hidden recording device in the light fixture installed in the jail's attorney room. The employee, who has asked to remain anonymous for fear of retaliation, discovered the device when a trustee removed the cover to service the light. A screw had been removed from the fixture, and the recording device was positioned under the cover to film footage through the screw hole.

After being told about this situation, I went to the jail to investigate and was able to confirm that the information provided was accurate. I am attaching photos taken of the attorney room light fixture, which clearly demonstrate that the device is installed exactly as was described by the employee.

I reported this information to the Oklahoma Attorney General so that a comprehensive investigation could be launched. However, a few days after reporting this matter, I again went to the attorney room and observed that although the wires were still present, the missing screw exposing the camera had been replaced.

The bugging of an attorney room is a clear violation of the Fifth and Sixth Amendments to the United States Constitution as well as Article Two Section Twenty of the Oklahoma Constitution. Any argument that the recording device might have been installed for some legitimate purpose is easily refuted by the fact that it was concealed. The jail has an intricate system of appropriate security cameras, which are not hidden in any way. If the goal were to ensure the safety of attorneys, this could be achieved without any privacy violation through visual monitoring from a camera placed outside the window of the attorney room.

It seems apparent that this device was installed solely to violate attorney–client privilege. Until a thorough investigation is conducted, it is impossible to know how many accused persons have had their rights violated or how many trials or plea negotiations were unfairly impacted by knowledge gained because of this unlawful recording. In a civil society, it is essential to protect individuals' constitutional rights by holding those in positions of power to the highest ethical standard.

No one is above the law.
