NARRATIVE No: 1 - Officer: ANDERSON, BRYLUN

On March 23, 2022, at approximately 1320, I Deputy Anderson was dispatched to the jail for an incident in the jail.
When I arrived at the jail, I advised that inmate Mounga Mangisi was banging his head on the cell door in H-402 and trying to bite his finger off. With previous incidents with Mangisi being combative with jail staff and other Deputies, I armed myself with my less lethal 40mm bean bag launcher. I went to cell H-402 and advised Mangisi that we would be opening the door, and he would sit in the restraint chair. I advised Mangisi that this would be his one warning to comply with my commands.
I advised Mangisi to walk to the back of the cell and turn away from me and face the wall. The cell door was then opened, the restraint chair was placed inside the cell, and I commanded Mangisi to sit in the chair. He was then restrained in the chair without incident.
