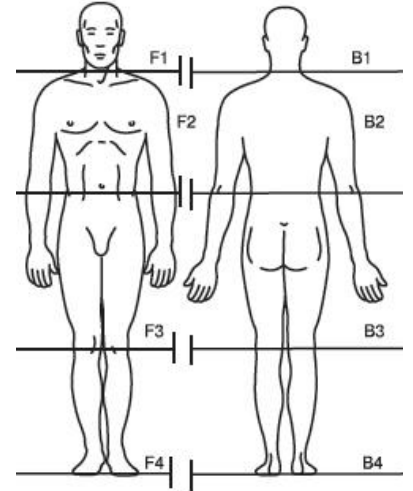

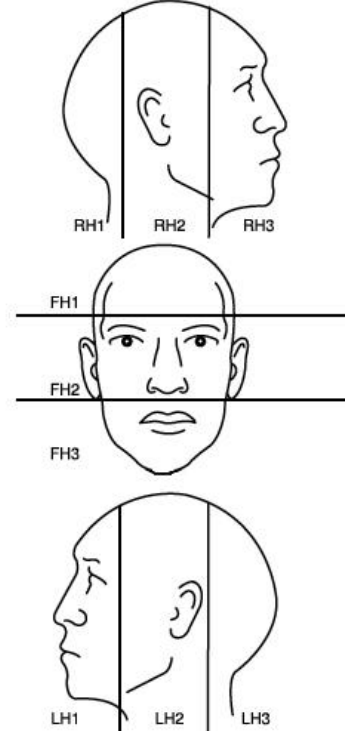

NARRATIVE No: 1 - Officer: WILLIAMS, ROY DEAN

On July 22nd, 2020, At approximately 12:12, Am I Deputy Roy Williams received a call from dispatch regarding an unruly inmate identified as Larry Torrez in the jail sharpening a metal object to make an edged weapon to use against jail staff and deputies.

When I arrived at the jail 100 South Washington Ardmore, Ok, I spoke with Sergeant Billy Mitchell, who explained we have an inmate in H-block who appears to have a metal object he intends to use as an edged weapon. Also, Torrez has his urine and feces readily available to throw at us if we have to go in to extract him. Billy decided since he has an edged weapon in the cell A taser may be needed during the extraction. I told Billy I would be the first one going into the cell, followed by him with a taser and then jail staff. I met with everyone before entering H-block for the extraction. The meeting was an effort to make a plan before the extraction. I explained to Detention officer Richard Ayers, Earnest Miller, and Rusty Martin, If there is no compliance and we had to go into Torrez's cell, I would be going in first with the shield then Billy Mitchell with the taser. After that, Lane Miller was the third man who would concentrate on Torrez's arms, followed by Richard Ayers fourth and Rusty Martin fifth who would concentrate on Torrez's legs.

At approximately 12:40 Am my self and those outlined above took up a stacked position in H-block cell #401. I opened the window hatch and observed Torrez in the cell with a large white cup full of what appeared to be urine in his right hand. I could not see his left hand. I asked Torrez to lay flat on the ground with his arms out like an airplane. Torrez refused. I asked Torrez again to get on the ground. Torrez stated, "I do not lay down for nobody mother fucker." I told Torrez to lay on his belly and place his arms out like an airplane a third time. Torrez refused and told me, "come and get some motherfucker." Billy Mitchell told Torrez to lay down on the ground, or we are coming in there to make you. Torrez refused and showed Billy he had a cup full of urine. I asked Torrez again to lay down on the ground so we could come in without incident. Torrez refused again. Billy asked Torrez again to get on the ground or he would be tazed. Torrez refused again and stated, "I do not get on the ground for nobody, you are gonna have to make me."

After approximately seven warnings the door latch was unlocked, Billy attempted to discharge his taser into Torrez. During the five-second burst, I did not believe the prongs had set right for a good connection. Torrez had a long delayed reaction to the taser, so I went in with the shield to smash Torrez's body down to the ground so we could gain control and detain him. After that, Torrez was dragged to the cell floor where I placed handcuffs on him, and martin, along with Ayers, placed ankle shackles on him. During the incident, Torrez began bleeding from the mouth. Dispatch was advised to get an ambulance on route to the jail to attend to Torrez's wounds. After the extraction was completed, I discovered that Torrez had removed the metal nozzle from the sink. Martin explained, Torrez had attempted to sharpen it down by rubbing it on the concrete. Doing so makes a sharp edge in which Torrez had threatened jail staff he would kill them with it.

The ambulance arrived and took Torrez to the Ardmore Mercy hospital emergency room. Mitchell and I followed behind the ambulance while martin rode in the back with Torrez. Torrez was attended to by mercy ER staff and released shortly after and taken back to the jail.

NARRATIVE No: 1 - Officer: MITCHELL, BILLY

On 07-22-2020 at approximately 1210 hours, I was advised by dispatch that detention officers in the jail were requesting my assistance with an unruly prisoner. I made contact with detention officers Richard Ayers, Earnest Miller and Rusty Martin in the jail. They informed me that Larry Torez, who is in H-Block cell #401, has taken the handle off of his sink and is attempting to sharpen it on the walls to be used as a weapon. They advised that Larry is acting very violent. They advised that Larry has made threats to several detention officers. I was advised that they had attempted to have Larry hand the handle through the bean hole several times. Larry refused. I was also informed that Larry has a cup full of his urine in the cell which he intends to throw at anyone who enters. I was also informed that Larry is in jail for threatening a Carter County Deputy and several Ardmore Police Officers with a knife. I was advised they needed help retrieving the faucet handle. Deputy Williams arrived on scene a short time later. I advised the detention officers that we would make every attempt to have Larry comply with our orders before we entered the cell. I advised them due to the fact that Larry has a weapon of sorts and a cup of urine I would carry a Taser in case the need arose to use it. Deputy Williams, myself and the above listed detention officers stacked up outside of cell #401. Deputy Williams carried a shield and was number 1 in the stack. Deputy Williams opened the window to the cell and ordered Larry to lay on the ground with his hands out to his side. Larry refused and cussed at him several times. Deputy Williams made several attempts to get Larry to comply with the same result. I then spoke with Larry in an attempt to get him to comply. Larry cussed me, showed me a cup in his hand which appeared to contain urine and told me to "come get some mother fucker". I again attempted to get Larry to comply and advised him that if he attacked us or attempted to throw urine on us he would be Tased. Larry continued to cuss me and tell me to come in. At that time the door was opened. I could see that Larry was in attempting to throw the contents of the cup on us. I deployed my Taser at that time. Larry took a few steps back and attempted to remove the prongs. At that time he appeared to complete the circuit and that Taser began to take effect. At that time Deputy Williams pushed Larry up against the wall with the shield where he fell to a seating position. Larry was pulled to the floor and detained at that time. I removed 1 prong from Larry. The other was not attached. I collected the spent cartridge and prongs as evidence. I could see that Larry appeared to be bleeding from his nose and mouth. SOAS was called to the scene. Pictures were taken of the cell and of the damage to Larry's face. The faucet handle was recovered. Larry was transported by SOAS to the Ardmore Mercy E.R. where he was medically cleared. No further action taken from this Deputy at this time.
