**FINAL ORDER OF REVOCATION**

The Council on Law Enforcement Education and Training (CLEET hereinafter), pursuant to 70 O.S. § 3311 and OAC Title 390 Chapter 2, does hereby enter this Final Order of Revocation in the above cause:

**FINDINGS OF FACT AND CONCLUSIONS OF LAW**

1. That Respondent is a certified Peace Officer in the State of Oklahoma.
2. That on or about October 12, 2022, Respondent was charged with one (1) count of Aggravated Assault (a class D Felony) in violation of ACA § 5-13-204(a)(1) in the Circuit Court of Washington County, Arkansas case no. 72CR-22-2395.
3. That on or about January 27, 2023, Respondent was entered a plea of Guilty to one (1) count of Aggravated Assault in violation of ACA § 5-13-204(a)(1) and received sixty (60) months of probation in the Circuit Court of Washington County, Arkansas case no. 72CR-22-2395.
4. That on or about November 3, 2022, CLEET issued a notice of summary suspension in this case and said suspension remains currently in effect.
5. That pursuant to 70 O.S. § 3311, "The Council shall revoke the certification of any person upon determining that such person has been convicted of a felony or a crime involving moral turpitude or a domestic violence offense or has entered a plea of guilty, or nolo contendere or an "Alford" plea or any plea other than a not guilty plea for a felony offense, a crime of moral turpitude or a crime of domestic violence or is the respondent in a final Victims Protective Order. . ."
6. That Notice of Intent to Revoke was mailed via certified, return-receipt requested, tracking number 7022 2410 0002 7191 2659, on September 19, 2023, to Respondent at his address on record with CLEET.
7. That on or about September 29, 2023, CLEET received the returned mail corresponding with certified mail tracking number 7022 2410 0002 7191 2659.
8. That no request for hearing has been received pursuant to OAC Title 390 Chapter 2.

9. That pursuant to 70 O.S. § 3311(P), individuals regulated by CLEET are obligated to maintain a current mailing address on file with CLEET and notices properly delivered to such address constitute good service.


### DISPOSITION

### NOTIFICATION OF APPEAL RIGHTS

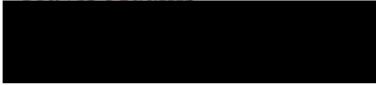

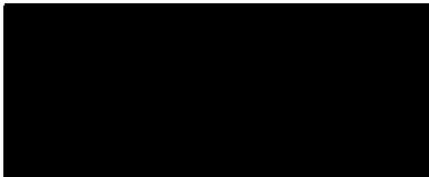
