FINAL ORDER OF REVOCATION

The Council on Law Enforcement Education and Training (CLEET hereinafter), pursuant to 70 O.S. § 3311 and OAC Title 390 Chapter 2, does hereby enter this Final Order of Revocation in the above cause:

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. That Respondent holds a fulltime Peace Officer Certification in the State of Oklahoma but that such certification was summarily suspended on or about November 16, 2021, pursuant to 70 O.S §3311(B)(19), because he was charged with a crime against a minor.
- 2. That on or about August 19, 2022, respondent was charged with two (2) counts of child abuse and one (1) count of interference with law enforcement in the District Court of Wabaunsee County, Kansas case no. WB-2022-CR-000068.
- 3. That on or about May 10, 2023, respondent entered a guilty or no contest plea to one (1) felony count of aggravated battery, one (1) misdemeanor count of battery, and one (1) felony count of interference with law enforcement.
- 4. Pursuant to the plea agreement filed on May 10, 2023, in the district court of Wabaunsee County, Kansas, respondent agrees to surrender his law enforcement certification.
- 5. That pursuant to 70 O.S. 3311, "The Council shall revoke the certification of any person upon determining that such person has been convicted of a felony or a crime involving moral turpitude or a domestic violence offense or has entered a plea of guilty, or nolo contendere or an "Alford" plea or any plea other than a not guilty plea for a felony offense, a crime of moral turpitude or a crime of domestic violence or is the respondent in a final Victims Protective Order. . .."
- 6. That Notice of Intent to Revoke was mailed via certified, return-receipt requested, tracking number on September 14, 2023, to Respondent.
- 7. That on or about October 30, 2023, CLEET received the returned letter corresponding with certified mail tracking number
- 8. That no request for hearing has been received pursuant to OAC Title 390 Chapter 2.

9. That pursuant to 70 O.S. § 3311(P), individuals regulated by CLEET are obligated to maintain a current mailing address on file with CLEET and notices properly delivered to such address constitute good service.

DISPOSITION

The Respondent's CLEET certification(s) is/are hereby revoked in accordance with OAC Title 390 Chapter 2 and pursuant to 70 O.S. § 3311.
