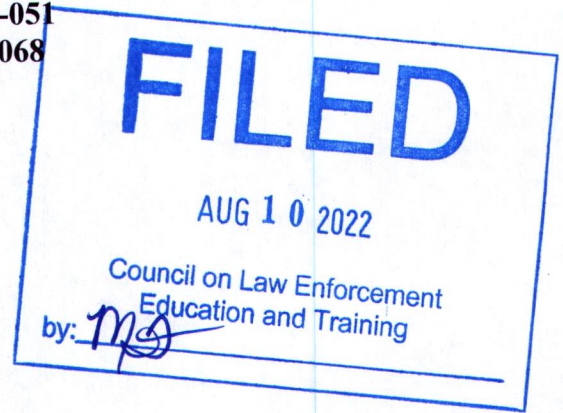

FINAL ORDER OF REVOCATION

The Council on Law Enforcement Education and Training (CLEET hereinafter), pursuant to 70 O.S. § 3311 and OAC Title 390 Chapter 2, does hereby enter this Final Order of Revocation in the above cause:

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. That Respondent is a certified Reserve Officer in the State of Oklahoma.
2. That on or about July 1, 2021, an Information charging Respondent with three (3) counts of Child Sexual Abuse was filed in the District Court of Grady County case no. CF-2021-179.
3. That on or about August 12, 2021, CLEET issued a notice of summary suspension in this case and said suspension remains currently in effect.
4. That the case which triggered the suspension (CF-2021-179 Grady County) is still pending with no disposition.
5. That on or about August 17, 2021, Respondent was named the Defendant in a Final Order of Protection in the District Court of Grady County case PO-21-122.
6. That pursuant to 70 O.S. 3311, "The Council shall revoke the certification of any person upon determining that such person has been convicted of a felony or a crime involving moral turpitude or a domestic violence offense or has entered a plea of guilty, or nolo contendere or an "Alford" plea or any plea other than a not guilty plea for a felony offense, a crime of moral turpitude or a crime of domestic violence or is the respondent in a final Victims Protective Order. ..."
7. That pursuant to 70 O.S. 3311, "The Council shall revoke the certification of any person upon determining that such person has received a deferred sentence for a felony, a crime involving moral turpitude or a domestic violence offense."

8. That Notice of Intent to Revoke was mailed via certified, return-receipt requested, tracking number 7020 0640 0001 4675 8594, on July 06, 2022, to Respondent at his or her address on file with CLEET.
9. That on or about July 18, 2022, CLEET received the signed green card corresponding with certified mail tracking number 7020 0640 0001 4675 8594.
10. That no request for hearing has been received pursuant to OAC Title 390 Chapter 2.
11. That Notice is deemed properly served.


DISPOSITION


