FINAL ORDER OF REVOCATION

The Council on Law Enforcement Education and Training (CLEET hereinafter), pursuant to 70 O.S. § 3311 and OAC Title 390 Chapter 2, does hereby enter this Final Order of Revocation in the above cause:

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. That Respondent holds a Fulltime Peace Officer certification in the State of Oklahoma.
2. That on or about August 15, 2023, Respondent was named the Defendant in a Final Order of Protection in the District Court of Canadian County case no. PO-23-325.
3. On or about August 15, 2023, Respondent was given a Final Protective Order with terms effective until August 15, 2028, in the District Court of Canadian County case PO-23-325.
4. That pursuant to 70 O.S. § 3311, "The Council shall revoke the certification of any person upon determining that such person has been convicted of a felony or a crime involving moral turpitude or a domestic violence offense or has entered a plea of guilty, or nolo contendere or an "Alford" plea or any plea other than a not guilty plea for a felony offense, a crime of moral turpitude or a crime of domestic violence or is the respondent in a final Victims Protective Order. . ."
5. That Notice of Intent to Revoke was mailed via certified, return-receipt requested, tracking number 7022 2410 0002 7191 3342, on September 25, 2023, to Respondent at his address on file with CLEET.
6. That on or about September 27, 2023, CLEET received confirmation from USPS Tracking with certified mail tracking number 7022 2410 0002 7191 3342,
7. That no request for hearing has been received pursuant to OAC Title 390 Chapter 2.
8. That pursuant to 70 O.S. § 3311(P), individuals regulated by CLEET are obligated to maintain a current mailing address on file with CLEET and notices properly delivered to such address constitute good service.

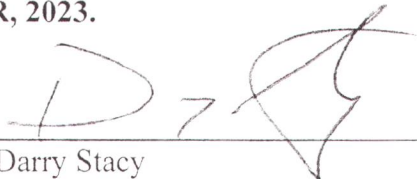
DISPOSITION

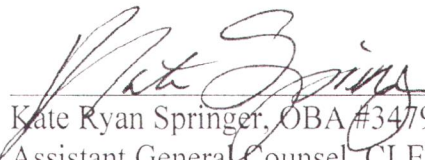
