when Carl Statt started working as a Police officer in Bokoshe he started coming in the cafe where me and my friend were working. He was really flirty toward us. We would joke around with him some but it didn't bother us. After my friend moved away he started following me and always asking me to talk to him private. He started always coming around where I was. At one point in about October or November he propositioned me asking me if I wanted to sleep with him. At first I took it as a joke until he continually was asking. He started ~~asking~~ stopping me just to talk. He took me ~~home~~ to my uncles on Bokoshe Hill one night to stay with my aunt. He picked me up and then started through the backroads of Bokoshe. He pulled over and got out of the police car and walked to the back of the car where I was sitting and opened the door. He then asked me if I wanted to have sex with him. I said Carl please take me home. He just kept standing there. I asked him again to take me home. He then asked me if it would help ~~if~~ he touched me and pointed toward my lower body. I just plainly told him to please take me home. He slammed the door, got in and drove me home to my uncles. He still always was around. A couple months later he stopped ~~me~~ by the pay phone where me and my friend Tiffany Morseth were using the phone and started

talking to me. He asked us to come to the police station where he was going. So we went down there to talk to him. This was approximately 4:30 - 5:00 am. He was just talking to him. He asked Tiffany to leave so he could talk to me in private. She left. At that time he picked me up and sat me on his desk. He stated kissing me on my neck & lips. He reached back and unsnapped my bra. I started telling him to quit. Karl was trying to pull my shirt off while trying to hold me. I pushed him away, while straightening my clothes. I took off out the door and left. I moved away at that time to stay with my dad. I came by to Bokoshe at the end of April. He is now following me. He has started asking me to talk alone again. About 2 months ago he asked me if I was still interested and I said no and left. Every since then he drives by my house and my aunts where I stay a lot. If I go for a walk he always stops me. He comes into where I work. When I drive through town he is right behind me. On July 17th 2001 he was in the cafe eating lunch and I came in. I was going home to tell my mom I had to work lunch hour when Carl told me he wanted to talk to me outside. So I said I was leaving anyway and he walked outside and then I walked out. He was waiting for me by my truck.
