**FINAL ORDER OF SUSPENSION AND REINSTATEMENT
FOR YEAR 2022**

The Council on Law Enforcement Education and Training (CLEET hereinafter), pursuant to 70 O.S. § 3311 and Rule 390:2-1-2, does hereby enter this Final Order of Suspension and Reinstatement in the above cause:

FINDINGS OF FACT(S) AND CONCLUSION(S) OF LAW

1. That Respondent holds a Fulltime Peace Officer Certification in the state of Oklahoma.
2. That pursuant to 70 O.S. § 3311 and CLEET Rule 390:27-1-2, Respondent must meet the annual Firearms Requalification requirement.
3. That Pursuant to 70 O.S. § 3311.4(A), Respondent, (if certified full-time and having been commissioned more than 90 days in the year 2022 as a full-time officer or combination of full-time and reserve officer), is required to have 25 hours of continuing law enforcement training catalogued by CLEET. At least two (2) of the 25 hours of continuing education must be on mental health issues and be cataloged for mental health credit, (mental health hours are included in the total hours).
4. That all continuing education and training requirements for the year 2022 and for the year must have been completed by December 31, 2022.
5. That pursuant to 70 O.S. § 3311.4(E), "Any active full-time or reserve certified peace officer, or CLEET-certified cross-deputized tribal officer who fails to meet the annual training requirements specified in this section, shall be subject to having the certification of the peace officer suspended..."
6. That pursuant Rule 390:27-1-6, "Failure to meet the annual requalification requirements shall subject the officer to disciplinary action in accordance with OAC 390:2."
7. That Respondent had not met two (2) Mental Health hours, Missing Persons, and Sexual Assault training requirements for the year 2022, and is subject to having his peace officer certification suspended.
8. Pursuant to 70 O.S. § 3311(J)(10)(c), "...Any person whose certification has been revoked, suspended or voluntarily surrendered for any reason, including failure to comply with mandatory education and training requirements, shall pay a reinstatement fee of One Hundred Fifty Dollars (\$150.00)."

9. That CLEET has the authority to promulgate Rules pursuant to Title 70 O.S. § 3311 et seq.
- 10. That CLEET has been provided satisfactory evidence of rectifying the deficiencies outlined in paragraph 7, and Respondent has paid the reinstatement fee. Respondent is entitled to reinstatement of his Peace Officer certification.**

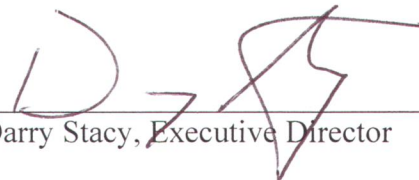
DISPOSITION
