I, Orvil Loge, the undersigned District Attorney of said County, in the name and by the authority of the State of Oklahoma, give information that in said County of Muskogee and in the State of Oklahoma, **CHARLES STANLEY PEARSON JR.** did then and there unlawfully, willfully, knowingly and wrongfully commit the crime(s) of:

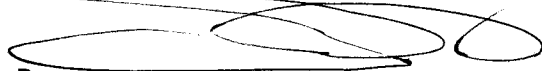
COUNT 1: FELONIOUSLY POINTING FIREARM ~ a FELONY, on or about the 7th day of June, 2020, by willfully pointing a Glock 22 .40 caliber handgun at John Pearson for the purpose of threatening or with the intention of discharging the firearm or with any malice or for injuring, either through physical injury or mental or emotional intimidation of for purposes of whimsy, humor or prank, or in anger or otherwise and for other than a lawful purpose, including an act of self-defense.

COUNT 2: CARRYING FIREARM WHILE UNDER THE INFLUENCE ~ a MISDEMEANOR, on or about the 7th day of June, 2020, by willfully carrying on or about defendant's person a Glock 22 .40 caliber handgun while defendant was under the influence of alcohol that would be sufficient to cause defendant's mental, emotional or physical processes to be affected to a degree that would result in abnormal behavior on defendant's part.

COUNT 3: RECKLESS CONDUCT WITH FIREARM ~ a MISDEMEANOR, on or about the 7th day of June, 2020, by demonstrating a conscious disregard for the safety of John Pearson and creating a situation of unreasonable risk and probability of death or great bodily harm to John Pearson by shooting John Pearson's vehicle while having in his possession a loaded Glock 22 .40 caliber handgun.

COUNT 4: DRIVING A MOTOR VEHICLE WHILE UNDER THE INFLUENCE OF ALCOHOL ~ a MISDEMEANOR, on or about the 7th day of June, 2020, by driving and operating a certain motor vehicle, to-wit: a 2006 Ford F150 bearing HUKEMUP, over and upon a public roadway at 7760 River Ridge Road, in Muskogee County, Oklahoma, while under the influence of intoxicating alcohol.

The undersigned upon oath deposes and states as follows, to wit:

Affiant advises that on the 7th day of June 2020 at approximately 1845 hours, the following incidents occurred at 7760 River Ridge Road

Muskogee County, Oklahoma.

Charles Pearson committed domestic abuse and feloniously pointing a firearm against the victim, his brother. In addition he fired a handgun into the victim's vehicle.

At approximately 2250 hours, Charles Pearson was apprehended in the 2700 block of, S. Woodland Road, while operating a motor vehicle. A Glock handgun was recovered from the vehicle and Pearson exhibited the following indicators of impairment: Unsteady on feet, bloodshot/watery eyes, and the presence of a strong odor of an alcoholic beverage upon his person. He was given Implied Consent and refused the State's Test by invoking his fifth amendment rights.

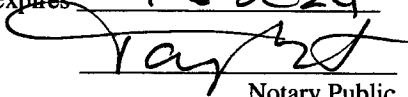
