Re: Citizen Complain against officer Valeria Banda Badge#757

To wit:

I am bringing a citizen's complaint against officer "Banda and Does" while on duty for Abuse of Authority: Insubordination; Misconduct; Cooperative Misconduct; Noncompliance with departmental procedures; Bias; Unlawful search; Deprivation of rights, Fraud in report writing, all while holding a civil service capacity with the Vallejo Police Department.

On or about February 19, 2025:

Officer Banda and another officer entered my home at 941 Pine St. two times, first at approximately 1836 hours and brought the family member out in cuffs at approximately 1840 hours, second at 1901 hours both officers regained entry to my residence after the adult resident was detained in their marked patrol car, then exited the property at approximately 1903 hours, Banda and the assisting officer I believe was Colman, both entered the property without consent of or all resident(s), it was no **Exigent circumstances, Emergency scene, Hot pursuit, or Imminent destruction of evidence nor was a warrant issued**, she was not given permission by the detainee to enter the home, per the watch commander she was the officer that led this unlawful entry into my home.

The resident was a victim to a crime, in which trauma occurred after the incident, Banda and others did not take this into consideration as the matter should have been handled by a special victim's unit, on how to interview a person after suffering a traumatic event. It also appears officer Banda held some form of resentment after reporting the matter to the watch commander, and through brief communication via email with officer Banda questioning her actions of the incident. Officer Banda actions appear to also be racially motivated as well, as to treat a person of color with deliberate indifference.

On or about May 1, 2025, at 2105 hours:

It was an incident at 1032 Atherton St, the house is located around the corner, it was quite alarming that a marked Vallejo Police car, would pull up directly in front of my home, shine over 1,000 lumens in my home, specifically in

1 my relatives room the one she detained and disturbed the entire residence, then at 2106 hours a second Vallejo
2 police unit pulled up and did the same thing?

3 I suspected the person responsible was officer Banda as she incorporated officer Saye, so I called and asked who
4 was the officers disrespectfully shining the light in my home, and to my avail, it was officer Banda along with an
5 officer Saye Badge ID#755, in which I felt she did this on purpose to be facetious/ or better yet trying to be funny, it
6 was no reason to disturb the peace of my home, it was done for only that of retaliation, harassment, intimidation and
7 racially motivated, the neighborhood or residence wasn't informed to either stay inside for a potential safety risk,
8 what if residents walked out, that person could have been harmed or mistaken for the potential suspect and killed by
9 these officers? Once again, these actions showed another alarming level of incompetence and deliberate misconduct
10 by officer Banda when handling incidents, and anything around my residence.

11 *Law enforcement is to set up a perimeter to establish a secure boundary around an area for security, safety, or to*
12 *control access, typically used for crime scenes, suspect searches, or dangerous situations. This usually involves*
13 *an inner perimeter to keep people out of the immediate incident area and an outer perimeter to block all vehicle*
14 *and pedestrian traffic, creating a safe zone for responders and limiting interference. The goals are to contain the*
15 *problem, prevent escape, protect the public, and maintain control of the scene. (Banda and Saye did not create a*
16 *sense of Safety they created a sense of retaliation/harassment/Intimidation of my household/home) Again a safe*
17 *zone for officers to operate and to protect the public from a suspect or dangerous situation was not established*
18 *here.*

19 **On or about June 16, 2025:**

20 I called Vallejo PD to report a potential kidnapping with a minor child that was being followed by an unknown
21 person in a car, Vallejo PD incident # 25-061-60084, I then received a call from officer V. Banda, I explained the
22 situation and that I had video of the acts, she began to say it was nothing she could do, I offered to send the video,
23 she snapped back I don't want to see no video, I stated to her that I would like her to investigate the matter and
24 check on the minor child. I asked for the above incident number to keep documentation, because her unbecoming
25 conduct again showed some form of bias against me as she acted like it wasn't nothing she could do, eventually she
26 showed up with another officer, she looked at me, turned her lip up then looked at the Black officer as if she had
27 said something negative to him prior about me, her face was turned up like umm, did a little head nod like here she
28 is, I immediately stated that I did not want to speak with her, do to her unbecoming conduct and negative types of

1 behavior, as an officer is questionable, I asked her for her immediate supervisor name, she acted like she didn't
2 know, and with a nasty attitude snapped back you can call the watch for that, the second officer did review the video
3 and agreed that something was wrong and did a wellness check on the child, I felt that if she would have followed
4 up she could have potentially discovered a child/sex trafficking incident, I felt she was the lead to this call because
5 she is the one that called me with the negative attitude, but in fact it's her blatant disregard, bias, retaliatory type acts
6 and racial type tendencies questions the ability of her being employed as an peace officer.

7 **June 21, 2025, 1836 hours:**

8 On or about June 21, 2025, same issue at the residence at 1032 Atherton, now an unknown Caucasian officer is
9 parked right in front of my home again overhead lights flashing? This is not securing a perimeter for a suspect, this
10 is harassment and continued intimidation. ***I would like that officer's name and badge number as well,*** I emailed
11 Banda about the first incident(s), and I believe she thought it was a joke to her and added other(s) to join in with the
12 cooperative misconduct for bringing concerns to the watch commander.

13 ***I am specifically requesting that officer Valeria Banda badge ID# 757 be removed from the South Vallejo patrol***
14 ***beat, and that she and other officers involved be placed under investigation and disciplined for her/their internal***
15 ***corruption, and willful neglect of duties mentioned in this complaint, it also raises a safety and security concern***
16 ***with her/does as well.***
