Synopsis:

On 02/02/2026 at approximately 1426 hours, Christian Fernando Camargo was arrested for violation of ARS 13-3415A. Christian was transported to the Gilbert Chandler Unified Holding Facility to be booked. Case Closed Criminal Citation.

Narrative:

On 02/02/2026 at approximately 1422 hours, I conducted a subject stop on a male later identified as Christian Fernando Camargo. I observed Christian riding a bicycle northbound on Alma School Road in the roadway, going with the flow of traffic. Christian then crosses the street and began riding northbound in the southbound lane, I observed no bike lanes on the north and southbound lanes. Violating ARS 28-815.

During the investigation, Christian was informed why he was stopped and stated he was going to the pawnshop to pawn a sword he had in a bag that was on his person. Christian gave consent to search his person and bag. During the search, a glass pipe with a bulb end was located in Christian's pants right pocket. The glass pipe appeared to be burnt, and had a white tint on it. Based on my training and experience, this type of pipe is commonly used to smoke narcotics. Christian was taken into custody at approximately 1426 hours and transported to the Gilbert Chandler Unified Holding Facility to be booked.

The glass pipe was seized and logged in as evidence, and stored at the Chandler Police Department Property building.

During the arrest search, three bank checks with his name on it. A separate case was opened for the checks to be investigated, see report 26-14145 for more details.

Christian's bike and luggage bag with the sword were taken into the Chandler Property building for safekeeping.
